



CONSULTORIO FAMILIARE – SPAZIO GIOVANI INFORMATION ABOUT THE PROCESSING OF PERSONAL DATA ART. 13 OF THE REGULATION (EU) 2016/679 – GDPR

By this note, the Local Health Unit provides the most important information concerning the processing of personal data within the activities of the Youths' Space and the Family Counseling Clinic), in compliance with the applicable regulations regarding privacy.

The general privacy policy and any additional information on the processing of personal data by the Local Health Unit (USL) of Modena is available on the institutional website www.ausl.mo.it/privacy.

LEGAL BASIS AND PURPOSES OF THE PROCESSING

The personal data (regarding the health and the sexual habits) requested are necessary to provide and manage the healthcare activities and are used by the staff of the youths' space and family counseling expressly authorised, subject to professional secrecy and in compliance with the rules on Privacy.

As required by law, the processing of personal data and the data related to health shall be made by USL of Modena **without requiring the consent** of the person concerned for these purposes:

- protection of health, physical safety and socialassistance;
- implementation of administrative, accounting and management activities correlated to care programmes;
- health education in the context of sexuality and affectivity;
- monitoring of pregnancy;
- psychological, gynaecological and obstetric counselling;
- programming, control and assessment of health care activities;
- epidemiological and statistical activities;
- certification activities;
- petition/ complaint/ controversy management

The processing operations may involve the health data of the newborn child.

Other specific personal data processing operations are made only if the person concerned gives the consent (for example for prenatal genetic advice, within the inter-company program "birth process", for scientific research purposes).

TO WHOM THE DATA MAY BE DISCLOSED WITH

To achieve the purposes indicate above and in the cases established by law, the personal data may be disclosed to public and private parties, (for example other entities involved during the diagnostic and treatment process, Social Service, law enforcement officials and judicial authorities).

The data collected during the performances received in any Family Counseling Clinic will be disclosed also with other Family Counseling Clinics in the province of Modena in case of any subsequent visits, in order to ensure high quality care and assistance. The data collected in the Youths' Spaces or the data related to the performances for the voluntary termination of the pregnancy are not made accessible to other Family Counseling Clinics in the territory.

METHODS OF PROCESSING AND DATA RETENTION PERIOD

The personal data provided are processed with the aid of computerised and/or paper means. The data are protected in order to guarantee their safety, their confidentiality and a limit access to authorized personnel only. The data shall be kept only for such time as may be required to achieve the purposes for which they were supplied.

THE SUBJECT'S RIGHTS

The subject is entitled to access his personal data and may request amendments if data are incorrect or incomplete. Furthermore, in the situations provided by law, the person may also ask the control of use of the data and may naturally exercise his right to object to the gathering and processing of the data. For that purpose, he may submit an application to the Data Protection Office of the Unit by writing to dpo@ausl.mo.it

On the above assumptions, he may also appeal with a complaint to the Authority for the protection of personal data, in accordance with the procedures established.
