

FORENSIC PATHOLOGY AND RISK MANAGEMENT INFORMATION ABOUT THE PROCESSING OF PERSONAL DATA

ART. 13 OF THE REGULATION (EU) 2016/679 – GDPR

By this note, the Local Health Unit provides the most important information concerning the processing of personal data within the activities of Forensic Pathology and Risk Management, in compliance with the applicable regulations regarding privacy.

The general privacy policy and any additional information on the processing of personal data by the Local Health Unit (USL) of Modena is available on the institutional website www.ausl.mo.it/privacy.

LEGAL BASIS AND PURPOSES OF THE PROCESSING

The personal data requested are necessary to provide and manage the healthcare activities and are used by the staff of the Forensic Pathology and Risk Management Department, expressly authorised, subject to professional secrecy and in compliance with the rules on Privacy.

The activities of this Department are required by law and, for this reason, the processing of personal data shall be used **without requiring the consent** of the person concerned.

The personal data processing takes place for the purpose of programming and performing outpatient visits, at the request of the person involved or a public entity. The data are processed for these purposes:

- Protection of individual and public health by the issuance of medical certificates (for the driver license, for the weapons licence etc.);
- Recognition of disability (assessment of civil disability, blindness, deafness, handicap, personal disadvantage for work placement reasons);
- Protection of individual and public health through the assessment of mental and physical health to drive motor vehicles, motorcycles and nautical

TO WHOM THE DATA MAY BE DISCLOSED WITH

In respect of the service provided by the Forensic Pathology and Risk Managemet Department the data may be communicated to these categories of parties:

- <u>Public entities</u>: The health authority (Mayor), judicial authorities, judicial police, the Prefecture, the Police Headquarters, the Traffic Control Authority (Motorizzazione Civile), the Region, other Health Authorities, INPS, INAIL, the Province, the Municipality;
- <u>Other private subjects</u>: the employer, the employers' organisations (delegated by the person concerned);
- <u>Other subjects</u>, public or privates, envisaged by law or regulations

METHODS OF PROCESSING AND DATA RETENTION PERIOD

The personal data provided are processed with the aid of computerised and/or paper means. The data are protected in order to guarantee their safety, their confidentiality and a limit access to authorized personnel only. The data shall be kept only for such time as may be required to achieve the purposes for which they were supplied.

facilities for people with medical conditions or subjected to extraordinary audit by the competent authority for the infringement of specific articles of law;

- Investigation of the Application to obtain recognition to compensation for permanent injuries caused by vaccinations, transfusions, administering blood products, according to L. 210/92 and s.m.i.;
- Medical Board to assess employability (job change or early retirement for health reason).

THE SUBJECT'S RIGHTS

The subject is entitled to access his personal data and may request amendments if data are incorrect or incomplete. Furthermore, in the situations provided by law, the person may also ask the control of use of the data and may naturally exercise his right to object to the gathering and processing of the data. For that purpose, he may submit an application to the Data Protection Office of the Unit by writing to dpo@ausl.mo.it

On the above assumptions, he may also appeal with a complaint to the Authority for the protection of personal data, in accordance with the procedures established. The data controller of personal data is Azienda USL of Modena, located in via San Giovanni del cantone, 23.
